- Complete the accompanying Risk Assessment Form and Camping Form (if appropriate).
- Invoices are sent within two weeks of receipt of Application Forms and is confirmation of your acceptance. The Invoice is payable within 10 days from date of issue and all monies paid are non-refundable.
- A copy of your PLI for £2M **must be sent to us by 15 June 2018**. We appreciate some insurances may be due for renewal after this date and before Fibre-East - in these cases, **you must inform us** and provide a copy as soon as it becomes available.
- If we have not received your Insurance or notification of its renewal date - **you will not receive your Stallholder Pack** and we will assume you no longer wish to attend and your space will be released to the waiting list and **all monies paid forfeited**.

Reminder emails will no longer be sent.

Key points on this sheet:

Application Form: Ensure the contact details you wish us to use for post and emails is on the form.

Invoices: Are issued within two weeks of receipt and approval of Application. Payment is then due 10 days from date of Invoice.

Insurance: A valid copy of PLI for £2M is required by 15 June 2018 - if after this date, we must be informed of the renewal date and **you must ensure we have a copy** on our files before the Event dates. **No reminder emails will be sent.**

Stallholder Packs: Will **NOT** be sent out if we do not have a copy of your insurance or notification of a renewal date. **No reminder emails will be sent.** You cannot attend Fibre-East unless we have your insurance on file and all monies paid will be forfeited.
